Further, submission of an online application shall not confer any right of participation, selection or appointment, which shall remain subject to scrutiny of eligibility, verification of documents, availability of posts, and approval of the competent/Appointing Authority.

Candidates shall deposit the prescribed examination fee only through Debit Card / Credit Card / Net Banking by accessing the Payment Gateway link provided in the online application system.
