"INSTRUCTION/ GUIDELINES

& Specimen Forms"

The Board has fixed the schedule of counselling for admission to 2 years Diploma in Elementary Education Session 2024-2026 for filling up of seats of Government DIETs and Privately Managed Institute affiliated with HPBOSE. The counselling shall be held w.e.f. 18-09-2024 to 20-09-2024 at Board Headquarter Dharamshala from 10.00 AM onwards. The list of candidates being called for the counselling date-wise is available on Board's Website www.hpbose.org. The counselling shall be held taking into consideration the following components as already given in the CET-2024 Prospectus: -

Eligibility:

- (A) Senior Secondary School Certificate (10+2) or its equivalent examination with at least 50% marks.
- (B) The relaxation of 5% marks in minimum education qualification is available to SC/ST/OBC/PHH candidates as per the rules and instructions of the State Govt.
- (C) The age limit will be between 17-32 years (i.e born between 10-06-1992 and 10-06-2007). Relaxation of 5 years in the upper age limit shall be given to the candidates of reserved categories.

The candidates are required to bring along with them their original certificates with attested photo copies thereof in support of their age, Academic Qualification, Proof of Domicile (Himachali Certificate) and the category to which they belong. The certificate to be produced in support of the category/Sub-Category/ requisite affidavit etc. to which they belong should have been issued by the competent authority on the prescribed from of the Govt.

- (1)) For EWS & BPL/IRDP candidates of General Category: Certificate of EWS should have been issued by the competent authority within 6 months as on the date of counselling. If candidate belongs Genral BPL/IRDP he/she should have BPL/IRDP certificate issued by the competent authority within 6 months countersigned by the BDO and Non-SC, ST, OBC certificate signed by competent authority. (Specimen-'E & F') form Tehsildar/Niab Tehisldar.
- (2) For IRDP (BPL) of SC, ST, OBC candidates: Certificate should have been issued by the competent authority within 6 months as on the date of counselling.
- (3) For SC/ST candidates: SC/ST certificate should have been issued by the competent authority.
- (4) For OBC candidates: OBC certificate should have been issued by the competent authority within 1 year as on the date of counselling. In case, the OBC certificate is more than 1 years, the OBC candidate shall submit an Affidavit (on Stamp Paper of Rs.5/-) duly attested by the 1st Class Magistrate/Oath Commissioner stating 'That his/her status has not been changed and he/she is not excluded from the category of Other Backward Classes (OBC) on account of being covered under Creamy Layer' as per the instructions issued by the Govt. of HP. The specimen of Affidavit is given as Specimen-'C'.
- (5) For Ex-serviceman: Discharge Book (with attested copy)/Certificate from Dy. Director, Sainik Welfare Officer of the District concerned.
- (6) For Wards of Ex-serviceman: (A) Latest certificate from the Patwari/Pradhan of Gram Panchayat/President of Municipal Committee or Notified Area Committee/Executive Officer of the Municipal Corporation of the area duly countersigned by the Tehsildar/SDM of the area & (B) Latest Affidavit (on Stamp Paper of Rs.5/-) duly attested by the Tehsildar/SDM of the area on the prescribed form. The specimen of certificates is given as Specimen-'A&B' respectively.
- (7) For Physically Handicapped: Minimum 40% disability. Medical certificate issued by the Medical Board duly countersigned by the C.M.O.
- (8) For Children/Grand Children of Freedom Fighter candidates: Certificate issued by the competent authority. (Specimen-'D')
