
हिमाचल प्रदेश स्कूल शिक्षा बोर्ड की 115वीं बैठक दिनांक 19/11/2019 की कार्यवाही की मद संख्या 20(7)1 व 2 के अंतर्गत विचार विमर्श उपरान्त माननीय बोर्ड ने परीक्षा विनियम के अध्याय 14 के नियम 14.2.3 व अध्याय 4 के नियम 4.12.4 में प्रस्तावित निम्नलिखित संशोधन को अनुमोदित करने का निर्णय लिया है।

14.2.3	Chairman/Secretary may permit correction in spelling errors, factual errors, typographical errors in candidate's name, surname, father's name, mother's name to make it consistent with what is submitted online and what is given in school records. They may also permit correction in case of genuine clerical mistakes. Representation in these cases will be sent by Principal or Head of the Institution or In-charge of Study Centre of HPSOS within one year from the date of declaration of result. Such cases shall be processed through examination branch concerned and no fee will be charged from the candidates. Correction/ change in Date of Birth will be allowed under rule 14.6 & 14.7.	Chairman/Secretary may permit correction in spelling errors, factual errors, typographical error in candidate's name, surname, father's name, mother's name to make it consistent with what is submitted online and what is given in school records. They may also permit correction in case of genuine clerical mistakes. Representation in these cases will be sent by Principal or Head of the Institution or In-charge of Study Centre of HPSOS with in stipulated period i.e. between the date of issuance of Admit card and the date of declaration of result. The applications received thereafter for correction in particulars of the candidate shall be entertained upto two months from the date of declaration of the result with the penal charges of Rs. 50/- per candidate. Such charges shall be realized from the concerned Principal/ Head of the Institution. Such cases shall be processed through Examination branch concerned. After the expiry of the stipulated period, all corrections will be made by the General Branch. Correction/change in Date of Birth will be allowed under Rule 14.6 & 14.7 of Examination regulation.

4.12.4	In case a candidate is admitted to a government hospital due to sudden illness or injury during the course of examination, a chance may be awarded to him for appearing in Written /Practical examination, of the paper missed by him, provided the medical certificate of the candidate is countersigned by the Chief Medical officer.	In case a candidate is admitted to a government hospital due to sudden illness or injury during the course of examination, he/she shall be allowed to appear along with the candidates of Supplementary Examination of the same year in Written/Practical examination of the paper missed by him, provided the medical certificate of the candidate is countersigned by the Chief Medical Officer. Such candidate who has appeared in Supplementary Examination in more than one subject and does not succeed to clear the all appearing subjects shall be treated as fail. But if their remains one subject to clear the examination, a candidate shall be placed under compartment. In such a case, a candidate placed under compartment may appear only in the March Examination of the succeeding year in that subject. A candidate(s) shall be charged notified/prescribed fee for each of the Examination, viz. annual and supplementary separately. The Chairman may, however, order a special examination or re-examination in one or more subjects any time as may be decided by him, according to the exigencies of the situation with fee of Rs.1000/- per theory examination and Rs.500/- per practical examination.
