### Terms & conditions: -

- 1. That the Board reserves the right to abolish the centre without giving any prior notice after it has been created, if it is found that the prescribed conditions are not fulfilled or the examination centre is not functioning to the satisfaction of the Board.
- 2. That the Board examination will be conducted peacefully & smoothly without any disturbances.
- 3. That if cases of unfair means/mass copying are reported and the staff of examination centre is found indulged in helping the candidates to cheat, then such examination centre will be cancelled for a specified period or permanently.
- 4. That the CCTV cameras footage during Board exams must be preserved for at least six months, otherwise it would be tantamount to violating the sanctity of the board exams.
- 5. That the examination centre will be retained for next year based on whether the examination was conducted peacefully/smoothly and on depositing the requisite fees during prescribed time period, if applicable. Moreover, if any institute is suspended and after completion of specific period, such institute intending to be designate as examination centre to conduct D.El.ED examination, will have to go through the complete process of centre creation along with all requisite fees.
