## **Existing Rules** 18.1 Registration Procedure

#### 18.1 Registration Procedure:

Registration of the candidates with the Board shall be originate from regular students of 9 class and from 11 class studying in all the Schools/ institutions affiliated to the Board. Term and conditions for registration with the Board shall be as follows:

- 1. The registration fee shall be 50/-per student.
- 2. The last date to apply for the registration shall be 30 of December every year without late fee.
- 3. Last date with late fee of `100/- shall be 15 of January of every next year. No application/fee shall be accepted after due date without the permission of Hon'ble Chairman of the Board.

## Approved Rule 18.1 Registration Procedure

#### 18.1 Registration Procedure:

Registration of the candidates with the Board shall originate from regular students of 9 class and from 11 class studying in all the Schools/ institutions affiliated to the Board. Term and conditions for registration with the Board shall be as follows:

- 1. The registration fee shall be 50/-per student.
- 2. The last date to apply for the registration shall be 31st of October every year without late fee.
- 3. Last date with late fee of Rs 100/- shall be of Novermber of every year. application/fee shall be accepted after due date without the permission of Hon'ble Chairman of the Board.

In addition to this, the point No. 4 to 14 given in the rule 18.1 registration procedure will remain unchanged.
