## “Notification”


In exercise of powers vested in him under section 19(3) of the H.P. Board of School Education Act,1968 the Hon'ble Chairman, H.P. Board of School Education is pleased to amend the Rule 11.13 under H.P. Board of School Education Examination Regulations,1994 regarding appointment of Checking Assistant. The detail is as under:-

Existing Rule	Approved Rule
<p><b>11.13 CHECKING ASSISTANTS</b> Checking Assistants Shall be appointed by the Secretary from among the panel of Sub Examiners who will assist Head Examiners in Totaling marks, comparing the award lists with the answer scripts to ensure accuracy in the work and keeping watch that no portion of the script has remained unmarked. In case checking Assistant is not appointed by the Secretary then the Head Examiners will be competent to appoint Checking Assistant as per the guide-lines of the Board.</p>	<p><b>11.13 CHECKING ASSISTANTS</b> Checking Assistant will assist Head Examiners in Totaling marks, comparing the award lists with the answer scripts to ensure accuracy in the work and keeping watch that no portion of the script has remained unmarked. In case checking Assistant is not appointed by the Secretary then the Incharge of Spot centre/ Head Examiners / Single Examiner will be competent to appoint Checking Assistant as per the guide-lines of the Board.</p> <p><b>(a) Qualification for appointment of Checking Assistant:</b> Person having a graduation degree (in any stream) or equivalent qualification and serving in Government/ Semi. Government/ Department/ Institution recognized by the Government, will be eligible for appointment as Checking assistant.</p> <p><b>(b) The following categories of persons are not eligible for appointment as Checking Assistant to Head-examiners:</b></p> <ol style="list-style-type: none"><li>An examiner of same subject;</li><li>A person having relation with the head examiner;</li><li>A Student on the rolls of an institution;</li><li>A person whose close relative is appearing in the examination concerned; and</li><li>A disqualified/debarred teacher/person.</li></ol>
