## **"NOTIFICATION"**

It is hereby notified that the Himachal Pradesh Board of School Education (HPBoSE) is going to conduct the Eklavya Model Residential School Selection Test (EMRSST)-2026 for admission to Class VI in the Eklavya Model Residential Schools (EMRS) situated in the State of Himachal Pradesh. The said Selection Test shall be conducted exclusively for Scheduled Tribe (ST) students, in accordance with the provisions of the Eklavya Model Residential Schools Scheme and the instructions issued by the competent authority from time to time. Candidates who are appearing in / have appeared in / have passed Class V (fifth) in December 2025 or March 2026/ who have passed 5<sup>th</sup> class during the academic session 2025-26, and who belong to the Scheduled Tribe category, shall be eligible to apply. In addition, children belonging to all other categories who have lost their parents due to LWE/insurgency/COVID-19, children of widows, children of Divyang (Persons with Disabilities) parents, land donor children, orphan children, etc., shall also be eligible to appear in the examination, subject to fulfilment of the prescribed eligibility conditions and applicable as per norms.

In continuation of Notification No. दिशिका (37) DEB/TET Exam 5167-74 dated 10-12-2025, it is hereby further notified that the date of the EMRSST-2026, earlier scheduled for 26-04-2026, has been re-scheduled to 29-03-2026 in compliance to letter no. TBD(EMRS)(A)1-1/2026 dated 8-1-2026.
