"NOTIFICATION"

The Chairman, Himachal Pradesh Board of School Education, in exercise of the powers vested in him under Section 19(3) of H.P. Board of School Education Act, 1968 is pleased to further amend the rule 18.1 of Chapter 18 of H.P. Board of School Education, Examination Regulation 1994 updated up to July, 2017.

18.1 Registration Procedure	18.1 Registration Procedure
18.1 Registration of the candidates with the Board shall be originate from regular students of 9 class and from 11 class studying in all the Schools/ institutions affiliated to the Board. Term and conditions for registration with the Board shall be as follows : 1. The registration fee shall be 50/-per student. 2. The last date to apply for the registration shall be 15th of October every year without late fee. 3. Last date with late fee of Rs 100/- shall be 15th of November of every year. No application/ fee shall be accepted after due date without the permission of Hon'ble Chairman of the Board.	18.1 The registration of the students with the Board shall be originate from 9th class and from 11th class studying in all the schools/institution affiliated with the Board and for students who migrated from other Boards/universities : a) The registration of class 9th shall be valid till completion/passing of Matriculation examination. b) The registration of class 11th shall be valid till completion/passing of Senior Secondary (10+2) examination. c) A student migrating from other Boards/universities and directly admitted in Class 10th or 12th shall also have to registered with the Board as fresh candidate. Terms and conditions for registration with the Board shall be as follows: 1. The registration fee shall be ₹200/-per student. 2. The last date (without late fee) for registration with the Board shall be 15th of October, every year. 3. Fee of ₹500/- shall be charged as late fee after due date till 15th November, every year. No application/ fee for registration shall be accepted after due date without the prior permission of the Chairman.

Rest of the terms and conditions for registration laid down in rule 18.1 of Chapter 18 shall remain unchanged.
