1. **Two-Bid System:** The Quotations must be submitted in two parts:
 - o (a) Pre-qualification bid – *Annexure-B*
 - o (b) Price bid – *Annexure-A*Both bids must be submitted in separate sealed envelopes marked accordingly and enclosed in a single envelope clearly super-scribed as "*Quotations for supply of Sanitary items.*"
2. Sealed quotations addressed to the Secretary, HP Board of School Education Dharamshala (Kangra)-176215 must reach in the office of HPBOSE on or before **09th April 2026 at 05.00 P.M.**
3. The **Pre-qualification Bid** will be opened on **10th April 2026 at 2:00 PM** by the designated bids opening committee in the presence of bidders or their authorized representatives.
4. Quotations not conforming to the eligibility requirements/checklist will be rejected outright.
5. Price Bid of only those bidders will be opened who qualify at the Pre-qualification stage.
6. The bidder must have **valid PAN, GST Number.**
7. Rates should be inclusive of all taxes. If GST or other taxes become applicable during the contract period, they will be implemented as per Govt. directives.
