The categories of examination centres are as under: -

- A- Centre for +1/+2 in colleges
- B- Centre for +1/+2 in schools
- C- Centre for Matric

- The detail of requisite fees shall be available on the school id and said fees shall be submitted only through the link provided at concerned school id's. Fees received through any other mode may not be accepted.
- The said fees is mandatory to deposit within determined time period failing which necessary action will be taken as per rules.
