Notification

It is hereby notified that the Himachal Pradesh Board of School Education (HPBOSE) will conduct the Class 8th, 10th, and 12th examinations under the Himachal Pradesh State Open School (HPSOS) for the March 2026 session. Accordingly, the process of online registration and submission of admission forms will commence from 10th October of 2025. All eligible candidates intending to appear in these examinations are required to visit their nearest HPSOS Study Centres within the prescribed timeline to complete the registration and online form filling formalities. For these exams, the schedule for online registration and admission form submission is as follows:

The schedule for Re-appear and Improvement examinations (within one year) under HPSOS will be communicated separately through a distinct circular, to be issued subsequent to the declaration of the September 2025 HPSOS results. All concerned study centres are advised to await formal notification and refrain from initiating any related processes until official dates are announced.
