- The rates should be quoted inclusive of all taxes and F.O.R. to Board's office. Rates are to be quoted at Annexure A. The rates shall be effective for one year from the date of award/supply order.
- 2 Description of item for which rates are to be quoted is mentioned as Annexure-A. Bidder may inspect the machine on any working day with the prior permission of AS (store).
- 3 Unsealed quotation (will not be considered and will be rejected straightway.
- 4 Quotation must be accompanied with copy of GST registration number. Bidder is also requested to enclose the copy of PAN as per constitution business (for example sole Proprietor/Firm/Company).
- 5 After repairing Parts/changing the parts, old parts should be handed over to the Board's office.
- 6 Warranty of parts should be for at least six months or for a period as per the policy applied to items in question whichever is higher.
- 7 Labour charges in any case shall not be payable. Price of the spare part shall be shown in the Bill separately if any part of the machine is changed which is beyond warranty/guarantee and AMC.
- 8 The Board shall not be responsible for any postal delays.
- 9 The Worthy Secretary reserves the right to accept /reject any of the Quotation without assigning any reasons.
- 10 If the work is found to be satisfactory then it will be got extended for further one year on the rates agreed earlier.
