'NOTIFICATION'

The Board has fixed the schedule of counseling for admission to 2 years Diploma in Elementary Education Session 2017-2019 for filling up of seats of Government DIETs and Privately Managed Institute affiliated with HPBOSE. The counseling shall be held w.e.f. 11.9.2017 to 25.9.2017 at the Headquarter of the Board at Dharamshala from 10.00 AM onwards. The list of candidates being called for the counseling date-wise is available on Board's Website www.hpbose.org.

The counseling shall be held taking into consideration the following components as already given in the CET-2017 Prospectus:-

Eligibility:

- (A) Senior Secondary School Certificate (10+2) or its equivalent examination with at least 50% marks.
- (B) The relaxation of 5% marks in minimum education qualification is available to SC/ST/OBC/PHH candidates as per the rules and instructions of the State Govt.
- (C) The age limit will be between 18-32 years as on 16.7.2017. Relaxation of 5 years in the upper age limit shall be given to the candidates of reserved categories.

The candidates are required to bring along with them their original certificates with attested photo copies thereof in support of their age, Academic Qualification, Proof of Domicile (Himachali Certificate) and the category to which they belong. The certificate to be produced in support of the category/Sub-Category to which they belong should have been issued by the competent authority on the prescribed form of the Govt.

- (1) **For IRDP(BPL)** candidates: Certificate should have been issued by the competent authority within 6 months as on the date of counseling.
- (2) **For SC/ST** candidates: SC/ST certificate should have been issued by the competent authority.
- (3) **For OBC** candidates: OBC certificate should have been issued by the competent authority within 2 years as on the date of counseling. In case, the OBC certificate is more than 2 years, the OBC candidate shall submit an Affidavit (on Stamp Paper of Rs.5/-) duly attested by the 1st Class Magistrate/Oath Commissioner stating 'That his/her status has not been changed and he/she is not excluded from the category of Other Backward Classes(OBC) on account of being covered under Creamy Layer' as per the instructions issued by the Govt. of HP. The specimen of Affidavit is given as Specimen-'C'.
- (4) **For Ex-serviceman**: Discharge Book (with attested copy)/Certificate from Dy.Director, Sainik Welfare Officer of the District concerned.
- (5) **For Wards of Ex-serviceman**: (A) Latest certificate from the Patwari/Pradhan of Gram Panchayat/President of Municipal Committee or Notified Area Committee/Executive Officer of the Municipal Corporation of the area duly countersigned by the Tehsildar/SDM of the area & (B) Latest Affidavit (on Stamp Paper of Rs.5/-) duly attested by the Tehsildar/SDM of the area on the prescribed form. The specimen of certificates are given as Specimen-'A&B' respectively.
- (6) **For Physically Handicapped**: Minimum 40% disability. Medical certificate issued by the Medical Board duly countersigned by the C.M.O.
- (7) **For Children/Grand Children of Freedom Fighter** candidates: Certificate issued by the competent authority.
